Terms & Conditions – IDREA Climathon 2026 Marathon

Event Participation & Eligibility

- By registering for the IDREA Marathon, Participants agree to comply with all event rules and instructions from event officials.
- Participants must meet all eligibility requirements as follows:
 - **3 KM Run** – Open to participants aged **14 years and above (non-timed category)**
 - **5 KM, 10 KM, and 21.1 KM Runs** – For adults aged **18 years and above. (Timed Categories)**
- Participants are responsible for ensuring they are physically fit to participate. Participation is at their own risk.
- If a registration is made on behalf of a minor, the parent or legal guardian confirms that the minor has permission to participate in the event and agrees that participation is subject to the review and approval of the Event Management Team. The parent or legal guardian further agrees that all Terms & Conditions applicable to participants shall also apply to the minor participant.
- **3 KM Run Guidelines:** The 3 KM Run is a non-timed category. Winners and results, if applicable, will be determined solely based on the official information and decisions provided by the Race Management Team. No external records, tracking applications, or unofficial timing sources will be considered.

Registration

- All participants must register through the official registration portal before the closing date.
- Registration is confirmed only upon successful payment.





- Tickets are non-transferable unless expressly authorised by the organiser.
- IDREA reserves the right to reject or cancel any registration without assigning reasons.
- International participants may be required to present valid identification and travel documents upon request.

Participant Responsibilities

- Medical clearance is advised before participation.
- Participants must follow all event rules, route instructions, and safety guidelines provided by the organisers.
- Participants must comply with instructions from race officials, medical personnel, volunteers, and safety staff always.
- Participants must complete the race within the official cut-off time. Organisers reserve the right to remove participants from the course for safety reasons.

Event Changes & Cancellation

- The organisers reserve the right to change the event date, venue, or route due to unforeseen circumstances, including but not limited to weather conditions or government restrictions.
- If the event is cancelled by the organisers, the **Cancellation Policy** will apply.

Ticket Purchase & Transfer

- Tickets are non-refundable except as stated in the **Cancellation Policy**.
- Confirmed registrations are non-transferable and cannot be modified unless expressly authorised by the organiser.

Safety & Conduct

- Disruptive, unsafe, unlawful, or unsportsmanlike behaviour may result in disqualification or removal from the event without refund.

Liability

- Participation is at the individual's own risk.
- Participants acknowledge that marathon running is a physically demanding activity involving inherent risks, including injury, illness, accidents, weather-related conditions, and other unforeseen hazards.
- The organisers are not liable for any injury, illness, or loss of personal belongings during the event.

Expo Day

- All participants are requested to bring any of their Government ID proofs such as Aadhaar Card / Driving License / Voter ID Card / Passport and show at the time of collecting their BIB, T-Shirt & Registration kit.
- There will not be any facility to get their BIB, T-Shirt and Registration Kit on the day of Marathon.





Media Release

- By participating in the event, participants grant **IDREA** the right to use photographs, videos, or other media featuring them for promotional purposes without additional permission or compensation.

Governing Law

- These Terms & Conditions shall be governed by and interpreted in accordance with the laws applicable in the jurisdiction where the event is held.

1. No Refund for Participant-Initiated Cancellations

2. Event Cancellation by the Organiser

If the marathon is cancelled by **IDREA** due to unforeseen circumstances, including but not limited to:

 - **Natural calamities** (floods, earthquakes, extreme weather, etc.)
 - Government restrictions or public health emergencies
- Participants will be entitled to a **full refund** of the ticket purchase price.

3. Refund Timeline

In the case of an organiser-initiated cancellation, refunds will be processed within **60 days** from the official announcement date of the event cancellation.
